Dr Athanasios Askitis, B' Vice-Chairman of the Board of Directors, independent non-executive member of the BOD:

Dr. Thanos E. Askitis, graduate of the Athens Medical School, PhD in Psychiatry from the University of Athens in the field of Social Psychiatry, has specialized in human sexual behavior and couples therapy in the United States.

Since 1985 he has been practicing clinical Psychiatry and Behavioral Psychotherapy until today and has worked as a clinical psychiatrist in several psychiatric clinics treating cases with major psychopathology.

Since 1987, through the media in Greece, she has spoken openly about mental health and sexuality issues, focusing on television programs for over 30 years, debunking the psychiatric stigma in Greek society.

He has written extensively in daily and Sunday newspapers and magazines. Since 1988, as a scientific collaborator in mental health for the Ministry of Education and the Ministry of Youth, he developed pilot programs for preventive mental hygiene and sex education, while he approached the above issues in several schools in the country, both public and private, with numerous speeches to parents' and guardians' associations. He gave more than a thousand lectures in his forty years of clinical psychiatric career in Greece and Cyprus on mental and sexual health issues, focusing on psychopathology and human behavioral disorders.
